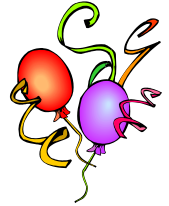

Small Animal Record Book Policy Change

Skunk Rabies Update

Skunk rabies testing is available on a fee-for-service basis at the Colorado Department of Public Health and Environment laboratory. They are also available for consultation on rabies exposure, testing, bite follow-up and reporting, and rabies pre and post exposure prophylaxis. You can submit skunks that are involved in pet animal or human exposure as part of local core public health activities. Submission of skunks showing signs of abnormal behavioral consistent with rabies is encouraged. Skunk testing criteria is domestic animal or human exposure, strange behavior (out during daytime, aggressive), dead less than 48 hrs, no maggots, head and skull intact. There is no need to submit normal behaving skunks; i.e., late night trash scavengers. Contact the Disease Control and Environmental Epidemiology Division at 303-692-2700 during business hours or 303-370-9395 after hours.

Launch into TARC and win!

Registration is now open for the *2009 Team America Rocketry Challenge*, the world's largest rocket contest challenging participants to compete for \$60,000 in prizes and scholarships and a trip to next year's international air show in Paris. Contest rules and registration are at www.rocketcontest.org. Participation is limited to the first 750 teams who register by Monday, December 1. The *Challenge*: Teams must design and build a rocket containing a raw egg that will climb to 750 feet and stay aloft for 45 seconds. This year's new task is transporting the one-egg payload lying on its side rather than positioned vertically, mimicking the position of an astronaut.

Students in grades 7-12 in any U.S. school or non-profit youth organization are eligible to compete. The rocket contest gives future engineers the opportunity to demonstrate their math and physics skills. Working together in a team environment, they will design a real aerospace product, which will be put through the rigors of testing and evaluation.

Chuck Urano Memorial Scholarship

The Colorado Farm Show will be awarding six \$2,000 scholarships to graduating high school seniors. Students must be pursuing a degree in an agricultural related field of study. Applications are available at www.ColoradoFarmShow.com and are due by January 5, 2009.

Living with Livestock

Beef Cattle Producer Class

There will be a producer class for both replacement heifers and market steers at the 2009 fair. Thanks to all those who participated this past year. Nominations have begun and run through December 31st. The rules and nomination procedure were outlined in online under the Livestock Program. Project or Club leaders should submit nominations to Jonathan at the Extension Office in the 4-H member's name.

Leased Livestock Procedures

Remember the numbers of leased animals are limited to two per 4-H'er. Also they developed a standardized universal lease form that will require the animal's tattoo or ear tag number to be listed on it. This lease form is universal and so anyone leasing an animal will need to use this form and have it on file at the extension office by May 1st. If you have additional requirements specified by the person who is leasing out their animal, you should add that info as a separate sheet, but this "universal" form must be filled out if they are leasing an animal for 4-H. These projects ideally should begin in October and go through September since only breeding animals can be leased.

Beef Weigh-In

The Beef Weigh-In will be held in early March. The date will be announced soon.

Meat Quality Assurance

If you are a first year senior or new to 4-H and you are taking **cattle, dairy, hogs, goats, sheep, rabbits, or poultry** you must attend a **meat quality assurance workshop**. Regardless of whether it is a market project or a breeding project you must attend a Meat Quality Assurance workshop. The first MQA Workshop will be held Wednesday, February 11th and will run from 6:30 p.m. to 8:30 p.m. at the CSU Extension Office. **4-H'ers who are 13 and under must have a parent stay at the MQA with them.** There will be two other MQA Workshops held in El Paso County. Those dates will be announced in future newsletters. Remember that if you are not able to attend a MQA Workshop in El Paso County you are welcome to attend MQA Workshops in other counties. Those counties will mail your certification to our office to show that you attended. However, Meat Quality Assurance certification must be completed 45 days prior to our County Fair. It is best to get this requirement accomplished early to avoid any unforeseen conflicts.

Country of Origin Labeling of Market Livestock Projects

Mandatory Country of Origin Labeling (COOL) was implemented starting on September 30, 2008 by the USDA. As a result, all cuts of beef, pork, lamb, goat, and chicken must have documentation as to the origin of the animals to be marketed in the U.S. and international meat industry. This act will require effective documentation of 4-H or FFA market animal projects that will be sold for meat purposes.

What will be needed by 4-Hers and FFA member are the tools to get the proper documentation. The documentation process is not that cumbersome and can be accomplished with a simple form which will be posted on the El Paso County 4-H web site under 4-H Livestock Program. This form may be used for animals which have been purchased or have been home grown. However, home grown animals will be required to have a record system to support the affidavit that will be outlined later in this article.

When the 4-Her or FFA member purchases a project animal, the individual should receive from the original owner verification of the source of the animal or have the original owner fill out and sign the affidavit. In addition, other supporting information that the buyer of an animal should maintain in their files could include Bill of sale, health papers, or brand inspections.

For home grown animals, responsibility for the documentation of origin will lie with the producer. A good start for the records documenting the source of an animal would include ear-tags or notches, recorded birth dates, or descriptions in birth records (calving books, PigChamp, PigTale, etc.). In most cases, these records should already be maintained by the parents involved in marketing livestock. Although not specifically required, other records that can be used for documenting home grown animals would include reconcilable inventory records, purchase and sale receipts, some financial or feed records, health papers, or breed association registered pedigrees. Current recommendations are that all records and affidavits be maintained on file by the 4-Her or FFA member for a **minimum of two years**. The goal is to provide an audit trail of the animal's origin in case verification is required by the USDA.

Compliance with these requirements should not place undo stress on the 4-H or FFA project owners. The 4-H records already required for market livestock projects will emphasize the types of information that will provide a good trail for any USDA audit. With the addition of an affidavit for any purchased animal, compliance with the latest USDA regulations should be very easily achieved.
