RULES:

Eligibility:

1. All 4-H members are eligible to participate. Creative Cooks is not restricted to members enrolled in foods projects.
2. Ages of Exhibitors:
Junior: Ages 8 to 10 as of January 1, 2008
Intermediate: Ages 11-13 as of January 1, 2008
Senior: Ages 14-18 as of January 1, 2008
Cloverbud: Ages 5 -7 as of January 1, 2008

Entries:

1. Complete rules and entry form will be included with fair book packet.
2. Entries are due **Wednesday, July 16**. Entries and recipe can be submitted by email, FAX, mail or in person.
3. **An accurate recipe for the food to be prepared must be submitted with the entry form.**
4. Participants will be notified by July 25 of their scheduled judging time.

Exhibit:

1. Participants will plan a menu for a meal and prepare 1 dish from the menu.
2. Entries in Colorado Specialty class must use one or more of the following specialty foods produced in Colorado: amaranth, quinoa, popped wheat, sesame seed, blue corn, sunflower seeds, Anasazi beans, mung beans, black turtle beans, adzuki beans, edible soybeans, or tofu. Game meat must be catchable (fish) or huntable (venison) in the wild. Venison must have copy of CWD test results.
3. A menu poster (no larger than 8-1/2 x 11") must be part of the display.
4. Exhibitors must provide the complete exhibit, including table, table covering, centerpiece, and appropriate place setting for the planned meal.

5. A food item can **NOT** to be used as part of the centerpiece.
6. Entire exhibit must fit within a 4' square area.
7. Cloverbud Division: Entries will plan a snack of a no-bake/no-cook snack. Snack will be displayed using appropriate table covering and place setting for the theme of the snack meal.

Judging:

1. Only contestants will be allowed in the preparation and judging area.
2. Exhibitors should be prepared to answer questions about menu, food preparation, and nutritional value of the menu.
3. Judging is on table display, creativity, nutrition, exhibitor appearance, menu, food safety, and appearance, flavor and quality of prepared food.
4. Exhibitors should dress appropriately for meal planned and/or theme of meal, and should be neat and well groomed.
5. After judging is completed, exhibits will remain on display for the public to sample entries. The member is to remain with the exhibit to answer questions until Creative Cooks is over. Failure to remain for public display may result in forfeiture of premium.

Awards & Premium:

1. Awards for junior, intermediate and senior divisions will be on the American System with placing given for 1st through 5th.
2. Premium will be \$3.00 for participation.
3. Awards will be announced at the conclusion of judging.
4. Champion entries in each class (except Cloverbuds) qualify to compete in Creative Cooks at the State Fair on Saturday, August 23.
5. State Fair Entries are due to the Fair Office by Wednesday, August 6 to allow scheduling of participants.

FOOD PRESERVATION

All canned foods must use standard canning jars. Screw bands can be used for transit but should be loosened and may be removed for judging.

Each label on a canned exhibit must include:

1. Name of product.
2. Method of preparation including type of pack, type or strength of syrup (if used), and use of any additional ingredients in the exhibit.
3. Method of processing (pressure or water bath).
4. Pounds of pressure, if pressure processed.
5. Elevation where processing occurred.
6. Processing time using the USDA times published in CSU Extension food preservation brochures.
7. Date processed (must have been completed since 2007 Morgan County Fair).

Each label on a dried food exhibit must include:

1. Name of product
2. Any pre-treatment used.
3. Listing of any added ingredients.
4. Method used for drying (oven, dehydrator, solar).
5. Total drying time
6. Date dried (must have been completed since 2007 Morgan County Fair).

CLOTHING CONSTRUCTION

Division 100
Department 120

EXHIBIT RULES:

1. An outfit shall consist of no more than 3 pieces.
2. NO accessory items (shoes, jewelry, hair decorations) can be included with the exhibit.
3. In Units 2, 3, and 4, clothing is defined as wearable dressy, or casual wear, active or sportswear, or sleepwear.
4. In Units 1, 2, 3, and 4 sergers may ONLY be used for a seam finish (not to make the seam).
5. Commercial pattern instructions **MUST** be included and be securely attached in binder. Instruction sheet **MUST** be labeled with member's name, county, and project unit.
6. Units 1, 2, 3, and 4 will be judged on the skills required for that unit.
DO NOT use skills that are required in a higher Unit.
Exhibits that exceed unit skills cannot be considered for Champion or Reserve Champion.
7. Extension Office will provide a label/tag to attach to garments. It **MUST** be sewn into garment at the neckline or waistline before exhibiting. Only Name and County should be included on label/tag for County Fair. Additional class and unit information will be added to the tag if exhibit is selected for State Fair.

CAKE DECORATING

EXHIBIT RULES:

1. Real cakes are required for Units 1, 2 and 4. Cake forms are preferred for other units.
2. Total exhibit size must be no more than 2' x 2'.
3. Cake **MUST** be on a very firm, disposable cake board that is no more than 1-1/2" larger than the dimensions of the cake. The cake board should be cut in the same shape as the exhibit cake. (NOTE: a 1/4" thick masonite board works best for cake boards).
4. Cake board should be covered with a food safe material (not freezer paper). The cake board cover should coordinate with colors and decorations of the exhibit cake. Refer to Cake Decorating 4-H Manual for information on cake board size and the procedure for covering cake board.
5. Units 1 through 4 should **not** use royal icing or rolled fondant as base frosting, but royal icing or fondant may be used for the decorations.
6. Units 1, 2, 3, 4, and 5 may NOT use any decoration items that are not edible.
7. Cakes will not be cut for judging.
8. Name, county and project unit **MUST** be on underside of cake board.
9. Pictures will be taken of all exhibits after judging. Pictures will be displayed with record books and ribbons.
10. All cakes in Units 1, 2, 4, and edible entries from other units will be sold with proceeds to be used for 4-H project training. Entries using cake forms will be returned to exhibitors. Indicate whether cake form is used.
