EXHIBIT RULES:

Eligibility:

1. Competition is open to the world.
2. Exhibits must be grown by the exhibitor.

Entries:

1. Entry fee for all classes is 50¢ per exhibit.
2. Superintendents may establish a class for one type of exhibit that is represented by three or more entries being from three different individuals.
3. Superintendents may combine two or more classes if there are less than three exhibits in each of the classes and the type of exhibit is similar enough that judging will not be compromised.
4. All exhibits must be grown by the exhibitor and shall be the crop from the current year unless otherwise noted.
5. 4-H and FFA exhibitors must show separate entries in Junior Field Crops and Open Field Crops with the exception of Junior Class 65 Alfalfa Hay which may be entered in Open Class 50 or 51 Alfalfa Hay.
6. Exhibitors may enter only two exhibits per class. If both entries place, only the top place will be eligible to receive a premium and show points.
7. Due to lack of space, only first through third place entries will remain on tables after the show. All other entries must be picked up by the exhibitor immediately following the show or they become the property of the Morgan County Fair.

Judging:

1. Exhibits will be judged according to their merit as based against industry standards for quality, regardless of the number of entries in a class.
2. Ribbons will be awarded for 1st through 5th placing in a class and may be picked up in the fair office the day after judging.
3. Sweepstakes Winners will be posted in the Mark Arndt Event Center.
4. Champion in each category and Grand Champion and Reserve Grand Champion for the show will be determined by points earned for placing 1st through 3rd with first place earning three points, second place earning two point and third place earning one point.

Premiums:

1. First place will earn \$3.00, second place will earn \$2.00 and third place will earn \$1.00.
2. Premiums may be picked up from Tuesday, August 19th through Friday, October 31st at the Morgan County Extension Office, 914 E. Railroad, Fort Morgan.

PECKS

Full measure required (approximately 2 gallon).

Entries must show in a Morgan County Extension peck box available at time of entry.

CORN STALKS

Picking and silage corn entries receive 50% of their score on preparation and 50% on quality of exhibit.

Preparation includes:

- cutting the plant uniformly at the internodes below the first set of brace roots, arranging so tassels and ears come together at one height and have stalks tied in three places for easy display
- remove all soil from samples
- select the tallest corn by measure from top of brace root
- only remnants of the brace roots should remain on the stalk.

16. 6 stalks, picking medium, 100 – 109 days, named variety
17. 6 stalks, picking late, 110 days, or more named variety
18. 6 stalks, silage, named variety
20. Tallest stalk of corn, named variety

FORAGE

1. Alfalfa hay, dairy standard exhibits, class 50, must be entered at the Extension Office no later than 5:00 p.m., Wednesday, July 16th. The laboratory test results will be provided to the exhibitor after the judging.
2. An exhibit shall be one standard bale, large bale, or rounded bale of 2008 production.
3. Judging will be based on analysis (class 50 only) and sensory characters, (leafiness, leaf retention, brittleness, color, absence of objectionable orders, weeds, or other foreign material), and bale conformation.

SHEAVES & VINES

1. Sheaves of small grain, grasses and millet shall be at least three inches in diameter at the center tie.
2. Sheaves or bundles of sorghum, sudan grass, alfalfa and clover should be at least six inches in diameter at the center tie and should be dry.
3. Small sheaves shall be judged on sheaf make-up.

EXHIBIT RULES:

Eligibility:

1. Competition is open to the world.
2. Exhibits must be grown by the exhibitor.

Entries:

1. Entry fee for all classes except Tiny Tots Division is 50¢ per exhibit.
2. Children under eight as of January 1, 2008 may enter the Tiny Tots Division at no fee. Entries will not be judged; however, all participants will receive a special event ribbon.
3. Superintendents may establish a class for one type of exhibit that is represented by three or more entries being from three different individuals.
4. Superintendents may combine two or more classes if there are less than three exhibits in each of the classes and the type of exhibit is similar enough that judging will not be compromised.
5. All exhibits must be grown by the exhibitor and be from the current year's crop unless otherwise noted.
6. 4-H and FFA exhibitors must show separate entries in Junior Garden and Open Garden Shows.
7. Exhibitors may enter only two exhibits per class. If both entries place, only the top place will be eligible to receive a premium and show points.
8. Due to lack of space, only first through third place entries will remain on tables after the show. All other entries are to be picked up immediately after the show; exhibits not picked-up become the property of Morgan County Fair.

Judging:

1. Exhibits will be judged according to their merit as based against industry standards for quality, regardless of the number of entries in a class. Manuals on selection, preparation and judging of vegetable exhibits are available from the Morgan County Extension.
2. Vegetables should show uniform stems when indicated. See individual class to determine if stems should be cut or broken at joint.
3. Ribbons will be awarded for 1st through 5th placing in a class and may be picked up in the fair office the day after judging.
4. Winners will be posted in the Mark Arndt Event Center.
5. Champion in each category and Grand Champion and Reserve Grand Champion for the show will be determined by points earned for placing 1st through 3rd with first place earning three points, second place earning two points and third place earning one point.

Premiums:

1. First place will earn \$3.00, second place will earn \$2.00 and third place will earn \$1.00.
2. Premiums may be picked up from Tuesday, August 21 through Wednesday, October 31 at the Morgan County Extension Office, 914 E. Railroad, Fort Morgan.

3. Superintendents may establish a class for one type of exhibit that is represented by three or more entries being from three different individuals.
4. Superintendents may combine two or more classes if there are less than three exhibits in each of the classes and the type of exhibit is similar enough that judging will not be compromised.
5. All exhibits must be grown by the exhibitor unless otherwise noted.
6. Exhibitors may enter only two exhibits per class. If both entries place, only the top place will be eligible to receive a premium and show points.

10. If there is a class for a flower variety, that variety may not be shown in any other class.
11. Exhibitors in the Floral Arrangement Division (classes 175-184) must provide their own containers.
12. Due to lack of space, only first – third place entries will remain on tables after the show. All other entries must be picked up by exhibitor immediately after the show or they become the property of the Morgan County Fair.

Judging:

1. Exhibits will be judged according to their merit as based against industry standards for quality, regardless of the number of entries in a class. Manuals on selection, preparation and judging of flower exhibits are available from the Morgan County Extension Office.
2. Ribbons will be awarded for 1st through 5th placing in a class and may be picked up in the fair office the day after judging.
3. Names of winners will be posted in the Mark Arndt Event Center.
4. Champion in each category and Grand Champion and Reserve Grand Champion for the show will be determined by points earned for placing 1st through 3rd with first place earning three points, second place earning two points and third place earning one point.
5. Best of Show will be the single best exhibit in the show selected by the judge.
