**Youth Helmet & Age Requirement Policy**

Summit County 4-H Sponsored Horse Shows require all youth (ages 8-18) to wear a certified equestrian helmet with safety harness fastened in place in over fences classes, gymkhana events, activities and practice sessions. Youth must be at least 8 years old by January 1 of the current year to participate.
